STUDENT BOUNDARY EXCEPTION REQUEST

Mr. Bleck had some policy samples for the board to take a look at to recognize board member participation in board meetings via remote access. There was consensus from the board to put together a sample policy to bring forward for potential approval at the next board meeting.

FINANCE OPERATIONS

2016-2017 CO-CURRICULAR GRID REVIEW

Mr. Bleck referenced an annual meeting that takes place in reference to the cocurricular grid and some potential additions that are being brought forward which include Elementary Fuel Up to Play 60, Elementary and Middle School Yearbook, and Elementary Drama. There were also a couple of positions that have been eliminated due to lack of student participation over the past couple of years.

2016-2017 NWEA BID WAIVER REQUEST/RENEWAL

QLIK SOFTWARE APPLICATION BID WAIVER REQUEST

Mr. Bleck referenced a request for a bid waiver for QLIK Software which would be used by the district to process district data and would cut down on man hours. This software could be used to take data from testing which can be used to pinpoint any gains or regression of grades or students and all information will be instant. This can also be used as a teacher effectiveness tool.

2016-2017 CESA 6 AGENCY SERVICES

Mr. Bleck referenced an invoice for purchased services from CESA 6 to support the district and student operations. The cost for 2016-2017 has gone up from last year due to additional services that are required for students.

PIZZA HUT SCHOOL LUNCH PARTNERSHIP

Mr. Bleck referenced a program for food service in which Pizza Hut pizza would be served as the hot lunch for one day per month. Pizza Hut has met all of the USDA requirements and they will deliver the pizza to the school on the day that the district chooses. Several districts in the area are currently involved in this program as well.
