Mr. Bleck noted that the district will be looking for a resolution authorizing the issuance and sale of the \$10,000,000 Bond. The district will go through the same process as we did in November for the first \$10,000,000. A resolution will be brought forward at the next meeting for potential approval.

DISCUSSION OF RESOLUTION AUTHORIZING THE ISSUANCE AND ESTABLISHING PARAMETERS FOR THE SALE OF NOT TO EXCEED \$10,000,000 GENERAL OBLIGATION REFUNDING BONDS
